Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 21, 2024, placed the rating(s) of Kashibai Solar Energies (KSE) under the 'issuer non-cooperating' category as KSE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KSE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 06, 2025, September 16, 2025, September 26, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The company has set-up a 1 MW solar photovoltaic (PV) power plant located in Malali village, Bagalkot district of Karnataka. The project achieved commercial operational from February, 2017. KSE has an entered into long-term power purchase agreement with Hubli Electricity Supply Company Limited.
