Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 11, 2024, placed the rating(s) of Jai Mata Dee Construction (JMDC) under the 'issuer non-cooperating' category as JMDC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JMDC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 27, 2025, October 07, 2025, October 17, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the firm

M/s. Jai Mata Dee Construction (JMDC) was set up as a proprietorship firm in 1979 by Shri Sanjay Kumar of Bihar for carrying out different types of construction activities. Subsequently in 1999, it was converted into partnership firm with induction of Shri Jitendra Kumar as partner, with equal profit-sharing ratio. JMDC is a small sized Bihar based firm engaged in providing different types of civil constructions in the segments like roads, commercial building, industrial buildings, railways, bridges, etc. for various government and semi government entities

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of JMDC into Issuer Not Cooperating category vide press release dated October 30, 2025 on account of its inability to carry out a review in the absence of requisite information.
