Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 10, 2024, placed the rating(s) of R.K. Pharmaceuticals (RP) under the 'issuer non-cooperating' category as RP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 26, 2025, November 05, 2025, November 15, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
