Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 12, 2024, placed the rating(s) of Srinivasa Feed Mixing Plant (SFMP) under the 'issuer non-cooperating' category as SFMP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SFMP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 28, 2025, October 08, 2025, October 18, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Ongole based Srinivasa Feed Mixing Plant (SFMP) was established in the year 2008 as a proprietorship concern by Mr. Syamu Bellam. The promoter has more than a decade of experience in the feed manufacturing industry. The entity is engaged in manufacturing of cattle feed with an installed capacity of 10 TPH with an actual capacity of 3000 TPM. SFMP sells the products to the customers located in Kerala, Tamil Nadu, Maharashtra, Telangana and Andhra Pradesh. The firm also supplies the products to Department of Animal Husbandry. The firm procures maize, broken rice from farmers in and around ongole and molasses from sugar cane factories.
