### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated November 12, 2024, placed the rating(s) of Sri Anjani Pipes Industries (SAPI) under the 'issuer non-cooperating' category as SAPI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SAPI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 28, 2025, October 08, 2025, October 18, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the Firm

Sri Anjani Pipes Industries (SAPI) was established in the year 2013 as a partnership firm, by Mr. G Sanjeeva Reddy and Mrs G Madhavi. However, the firm achieved commercial operations from October 2015. The firm is engaged in manufacturing different types of pipes i.e HDPE pipes of various sizes starting 63mm to 315mm, PVC pipes ranging from 25 mm to 350 mm and LLDPE pipes ranging from 12 mm to 16 mm, at Mehbubnagar district of Telangana state. These pipes are mainly used for irrigation works (micro and drip), water supply and gas supply. In addition to the said industries, the above-mentioned pipes are also used in the following sectors like drainage and telephone cable pipes used by telecom operators.
