### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 29, 2024, placed the rating(s) of Anantshree Polymers Private Limited (APPL) under the 'issuer non-cooperating' category as APPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. APPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 14, 2025, September 24, 2025, October 04, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the company

Anantshree Polymers Private Limited (APPL) was incorporated in 2011, by Kayan family belonging to Kolkata to set up a unit for manufacturing polypropylene (PP) / high density polyethylene (HDPE) based woven sacks. The unit was setup at an aggregate cost of Rs.9.55 crore and the company commenced operations from September 2013 onwards with an installed capacity of 3,285 metric tons per annum (MTPA).
