### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 17, 2024, placed the rating(s) of Boss Pharma (BP) under the 'issuer non-cooperating' category as BP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 02, 2025, November 12, 2025, November 22, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the firm

About the Firm Boss Pharma (BP), based in Baddi, Himachal Pradesh was established in March 2006 as a partnership firm. The firm is currently being managed by Mr. Pankaj Nandwana and Mr. Rajat Nandwana as its partners. BSP is engaged in manufacturing of pharmaceutical formulations in the form of powder namely paracetamol, diclofenac sodium and vitamin C at its manufacturing facility located in Baddi, Himachal Pradesh.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of BP into Issuer Not Cooperating category vide press release dated December 11, 2025 on account of its inability to carry out a review in the absence of requisite information.
