### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 11, 2024, placed the rating(s) of Plasma Metal Processing Private Limited (PMPPL) under the 'issuer non-cooperating' category as PMPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PMPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 27, 2025, September 06, 2025, September 16, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Incorporated in the year 2011, PMPPL is engaged in the business for manufacturing of plasma coated rebars, wire rods and wires. The commercial operation started from April 2019. The manufacturing facility of the company is located at Butibori, Nagpur.

**Status of non-cooperation with previous CRA:** ICRA has continued the rating assigned to the bank facilities of PMPPL under Issuer Not Cooperating category vide press release dated April 16, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
