Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 15, 2024, placed the rating(s) of Farmico Cold Chain And Logistics Limited (FCCL) under the 'issuer non-cooperating' category as FCCL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. FCCL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 31, 2025, September 10, 2025, September 20, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Company

Farmico Cold Chain & Logistics Limited (FCCL) was initially established as Wadhvani Cold Storage & Ice Plant in the year 1989. However, it was reconstituted as a private limited company in the year 2015 as 'Farmico Cold Storage Private Limited' and finally it got its present name with effect from January 2018. The company is engaged in the business of providing cold storage facility. The cold storage facility of FCCL is located at Nagpur, Mumbai. Recently the company has set up a distribution hub in Mumbai and farm level infrastructure in Nagpur. The company has set up IQF line for sweet corn, green peas and mixed vegetables and ripening chambers and frozen storage. In addition to this the company is coming up with logistic business and accordingly it has purchased 5 vans.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of FCCL into ISSUER NOT COOPERATING category vide press release dated May 29, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
