### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 27, 2024, placed the rating(s) of Ramdev Stainless Strips Private Limited (RSSPL) under the 'issuer non-cooperating' category as RSSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RSSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 13, 2025, October 23, 2025, November 02, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the company

Jodhpur (Rajasthan) based RSSPL, incorporated in May, 2010, is promoted by Mr Mohan Lal Agarwal along with his family members. RSSPL was formed with a purpose to manufacture Stainless Steel (SS) sheets & circles and utensils from SS flats.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of RSSPL into Issuer Not Cooperating category vide press release dated May 30, 2025 on account of its inability to carry out a review in the absence of requisite information.

CRISIL has continued the rating assigned to the bank facilities of RSSPL into Issuer Not Cooperating category vide press release dated July 23, 2025 on account of its inability to carry out a review in the absence of requisite information.
