Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 16, 2024, placed the rating(s) of A.K. Soni Hosiery Mills Private Limited (ASHMPL) under the 'issuer non-cooperating' category as ASHMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ASHMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 01, 2025, November 11, 2025, November 21, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

A.K Soni Hosiery Mills Private Limited (ASHMPL) incorporated in August, 2004 is currently being managed by Mr. Anand Kumar Soni, Mrs. Rajrani and Mr. Sanjeev Soni. Prior to ASHMPL, the promoters-directors were carrying out operations through a proprietorship firm 'A.K. Soni Hosiery Mills' (operational since 1971) engaged in similar business. The company is engaged in manufacturing of knitted fabric.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of ASHMPL into Issuer Not Cooperating category vide press release dated February 20, 2025 on account of its inability to carry out a review in the absence of requisite information.
