### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 18, 2024, placed the rating(s) of Saviour Mines And Minerals Private Limited (SMMPL) under the 'issuer non-cooperating' category as SMMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SMMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 03, 2025, September 13, 2025, September 23, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Saviour Mines and Minerals Private Limited (SMMPL) was incorporated in the year 2007 and taken over by Mr. Rama Krishnaiah Alam and Mr.U. Bhargav in 2013. The company is engaged in mining of granite and processing of granite slabs. SMMPL started its commercial operations from 2014 October. SMMPL has installed capacity of 15 tonnage p.a. The company has entered into lease agreement with Telangana State Government for mining under 4 hectares of granite land area located at Warangal for a tenure of 15 years. The clientele of the company covers Maharashtra, Karnataka, Andhra Pradesh, Tamilnadu and Orissa.
