Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 22, 2024, placed the rating(s) of A & T Infracon Private Limited (ATIPL) under the 'issuer non-cooperating' category as ATIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ATIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 08, 2025, October 18, 2025, October 28, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Initially formed as a partnership firm named M/s Chohtan Construction Company (CCC) in 1981, A&T Infracon Private Limited (ATIPL) changed its constitution to a private limited company w.e.f. May 25, 2011. A&T is involved in the construction and infrastructure related activities (mainly road works, earthen embankment and other allied construction activities). ATIPL was promoted by Mr Ashok Doshi and Mr Tej Ram Chowdhary who have almost three decades of experience in the construction industry. Post retirement of Mr Tej Chowdhary in October 2013, the company is managed by Mr Ashok Doshi and his wife Mrs Anita Doshi. The directors are also partners in M/s Rajwada Crush Metal, a partnership firm, engaged in crushing of stones and metals.
