### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 19, 2024, placed the rating(s) of Shree Ganesh Education And Welfare Society (SGEWS) under the 'issuer non-cooperating' category as SGEWS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SGEWS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 04, 2025, November 14, 2025, November 24, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Shree Ganesh Education and Welfare Society (SGEWS) is an educational society and was formed in April 08, 2011 under Societies Registration Act, 1860 with an objective to provide educational services by establishing and operating various educational institutions. The society operate colleges and school under the name of "Dev Rishi" in a single geography offering varied courses located in Saharanpur.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of SGEWS into Issuer Not Cooperating category vide press release dated February 25, 2025 on account of its inability to carry out a review in the absence of requisite information.

CRISIL has continued the rating assigned to the bank facilities of SGEWS into Issuer Not Cooperating category vide press release dated August 14, 2025 on account of its inability to carry out a review in the absence of requisite information.
