Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 22, 2024, placed the rating(s) of Kamala Board Box Private Limited (KBBPL) under the 'issuer non-cooperating' category as KBBPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KBBPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 07, 2025, September 17, 2025, September 27, 2025 and October 01, 2025, December 01, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of KBBPL have been revised on account of non-availability of requisite information. Revision also factored in admission of KBBPL for Corporate Insolvency Resolution Process recognized by NCLT filing made by operational creditor.

About the company

KBBPL was initially set up as a proprietorship firm 'Kamala Board Box' in the year 1984 by Mr. Subrata Das and Mrs. Ipsita Das. Subsequently, it was converted into private limited company with effect from February 23, 2006 and the name of the company changed to its present name. The company has been engaged in manufacturing of corrugated board boxes, used for packaging products. The manufacturing facility of the company is located at Kolkata, West Bengal.

Status of non-cooperation with previous CRA: ICRA has continued the rating assigned to the bank facilities of KBBPL into ISSUER NOT COOPERATING category vide press release dated September 03, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
