### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 28, 2024, placed the rating(s) of Sree Lakshmi Electrical Services (SLES) under the 'issuer non-cooperating' category as SLES had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SLES continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 14, 2025, October 24, 2025, November 03, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of SLES have been revised on account of non-availability of requisite information.

Sree Lakshmi Electrical Services (SLES) was established in the year 2003 as a proprietorship concern, promoted by Mr Chandra Mohan Reddy. However, the constitution of the entity changed to partnership firm in June 2013. Mr Chandra Mohan Reddy is the Managing Partner while his spouse Mrs Sowbhagya Lakshmi is the other partner of the firm. The firm is engaged in providing services like construction of substation works (132 Kv-220 Kv), transmission lines, electrical works, erection, testing and commissioning among others mainly for various power distributing companies (Discoms).
