Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated January 07, 2025, placed the rating(s) of S.S. Agro (SA) under the 'issuer non-cooperating' category as SA had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 23, 2025, December 03, 2025, January 09, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

Analytical approach: Standalone revised from Combined

Previously CARE has considered a combined view profiles of S.S. Agro and S. S. Overseas as both the entities (together referred to as 'S.S. Group') operate in the same line of business, are promoted by the same promoter group, have common management team and operational linkages. However, updated information is not available to ascertain financial linkages that warrant a continuation of combined approach.

About the firm

S. S. Agro (SSA) belongs to the S.S. Group, founded in 1990. The group primarily comprises of three entities - SSA, S. S. Overseas and S. S. Timber Traders. Both SSA and SSO are engaged in the processing of paddy and rice and also sell its byproducts like bardana, bran, husk, etc. Both SSA and SSO have their manufacturing units located in Jalalabad, Punjab.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of SSA into Issuer Not Cooperating category vide press release dated November 14, 2025 on account of its inability to carry out a review in the absence of requisite information.

CRISIL has continued the rating assigned to the bank facilities of SSA into Issuer Not Cooperating category vide press release dated January 16, 2025 on account of its inability to carry out a review in the absence of requisite information.
