### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 21, 2024, placed the rating(s) of Aditya Cold Storage (ACS) under the 'issuer non-cooperating' category as ACS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ACS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 07, 2025, October 17, 2025, October 27, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the firm

Andhra Pradesh based, Aditya Cold Storage (ACS) was established in 2012 and promoted by Mr. K. Ravi Kumar and Mr K. Anil Kumar. The firm is engaged in providing cold storage facilities i.e, for preserving agricultural products like pulses, chillies, grains, etc. at Vellaturu (V), Ponnalur (M), Kandukur, Prakasam Dist., and Andhra Pradesh. The major customers of the firm include its associate concern (Aditya Traders), farmers and local traders. 50% of the capacity is used to store the goods from its associate concerns and the remaining is used to store the goods belonging to the local farmers. The cold storage capacity is 5000 tonnes.
