### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 06, 2024, placed the rating(s) of MCSR Constructions (MC) under the 'issuer non-cooperating' category as MC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 22, 2025, November 01, 2025, November 11, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings. has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

MCSR Constructions (MC) was established in the year 2012 as a partnership firm. The firm has its registered office located at Madras Road, Kadapa. MC is engaged in construction of roads and building works. The firm procures its work orders through online tenders from state government of Andhra Pradesh and Telangana.

**Status of non-cooperation with previous CRA:** Acuite has continued the rating assigned to the bank facilities of MC into Issuer Not Cooperating category vide press release dated December 20, 2024 on account of its inability to carry out a review in the absence of requisite information.

CRISIL has continued the rating assigned to the bank facilities of MC into Issuer Not Cooperating category vide press release dated December 19, 2025 on account of its inability to carry out a review in the absence of requisite information.
