### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 20, 2024, placed the rating(s) of Gagan Agro And Rice Exporters (GARE) under the 'issuer non-cooperating' category as GARE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GARE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 05, 2025, November 15, 2025, November 25, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Gagan Agro and Rice Exporters was established as a partnership firm in 2014 and it is currently being managed by Mr. Sumit Singla, Mr. Rahul Garg and Mrs. Amandeep Kaur. The firm is engaged in processing of paddy at its manufacturing facility located in Sangrur, Punjab. It is also engaged in trading of rice.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of GARE under Issuer Not Cooperating category vide press release dated June 10, 2025 on account of its inability to carry out a review in the absence of the requisite information from the firm.
