### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 12, 2024, placed the rating(s) of Sree Gouriputra Agro Products Private Limited (SGAPPL) under the 'issuer non-cooperating' category as SGAPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SGAPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 28, 2025, November 07, 2025, November 17, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

### About the Company

Sree Gouriputra Agro Products Private Limited (SGAPPL) was incorporated as a Private Limited Company by Mr. Kudapa Chakrapani, Mrs. Kudapa Subbalakshmi and Mr. Kudapa Hemanth Nag in 2002. The company is engaged in the processing of rice and trading of paddy. SGAPPL's rice milling plant is located at Undrajavaram Village, West Godavari District, and Andhra Pradesh.

**Status of non-cooperation with previous CRA:** Brickwork has continued the ratings assigned to the bank facilities of SGAPPL to the 'issuer not-cooperating' category vide press release dated June 11, 2025 on account of its inability to carryout review in the absence of best available information from the company.
