Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 27, 2024, placed the rating(s) of Smt. Sonpatti Devi memorial Medical Trust (SSDMMT) under the 'issuer non-cooperating' category as SSDMMT had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSDMMT continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 12, 2025, November 22, 2025 and December 02, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The members of the trust are namely Mr. Kunwar Haribansh Singh, Mr. Lal Sahab Singh, Mr. Ramesh Singh and Mr. Durgesh Singh. The trust operates three colleges and one public school in Jaunpur. Colleges are affiliated to Uttar Pradesh Technical University and are approved by the All India Council for Technical Education (AICTE). The trust also operates a school in the name of Indravati Public School providing primary and secondary education. The school is affiliated to Central Board of Secondary Education.
