### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated January 13, 2025, placed the rating(s) of Gurunank Rice Industries (GRI) under the 'issuer non-cooperating' category as GRI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GRI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 29, 2025, December 09, 2025, December 19, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Gurunank Rice Industries (GRI) was constituted as a partnership firm in April 2004 by Mr. Gurubhej Singh Chawla, and Mr. Ajit Singh Chawla. Since its inception, the firm has been engaged in processing and milling of basmati, non-basmati rice (parboiled rice), broken rice, rice bran and husk. The manufacturing facility of the firm is located at Raipur, Chhattisgarh with aggregate installed capacity of 17520 metric ton per annum.
