Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 18, 2024, placed the rating(s) of Dudi and Company (DC) under the 'issuer non-cooperating' category as DC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 04, 2025, October 14, 2025, October 24, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

Bikaner (Rajasthan) based Dudi and Company (DC) was formed in 1996 as a partnership concern. Subsequently, there were changes in the partnership on April 2005 and currently, there are six partners in the firm. DC is engaged in execution of contracts related to road construction. It is registered as an AA class (highest AA class to lowest D) approved contractor from Public Work Department (PWD), Rajasthan, Rajasthan State Road Development Corporation (RSRDC) and Rajasthan Agriculture Marketing Board (RAMB).

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of DC into Issuer Not Cooperating category vide press release dated March 04, 2025 on account of its inability to carry out a review in the absence of the requisite information from the firm.
