### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 05, 2024, placed the rating(s) of G.G. Fashions (GF) under the 'issuer non-cooperating' category as GF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 21, 2025, October 31, 2025, November 10, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the Firm

G.G. Fashions (GF) was established in 2001 as a proprietorship concern by Mr. G. Kannan at Salem, Tamil Nadu. The firm is engaged in manufacturing of grey fabrics and supplies them to the garment manufacturers. Apart from manufacturing in its own facilities, the firm also outsources, for processing of fabrics viz dyeing, bleaching, warping, sizing etc.

**Status of non-cooperation with previous CRA:** Acuite has continued the rating assigned to the bank facilities of GF into Issuer Not Cooperating category vide press release dated November 05, 2025 on account of its inability to carry out a review in the absence of the requisite information from the firm.
