### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 14, 2024, placed the rating(s) of Rajendra Agro Industries (RAI) under the 'issuer non-cooperating' category as RAI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RAI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 30, 2025, October 10, 2025, October 20, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the company

Raichur based, Rajendra Agro Industries (RAI) was established on May 24, 2017. The firm is engaged in the cotton ginning and pressing activity. Due to seasonal nature of raw material, the company operates for only 9 months in a year and remains closed in the months of July, August and September. The manufacturing unit of the firm is located at Raichur, Karnataka.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of RAI into Issuer Not Cooperating category vide press release dated April 02, 2025 on account of its inability to carry out a review in the absence of the requisite information from the firm.
