### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated October 25, 2024, placed the rating(s) of GVR Khandaphod Bijwad Road Project Private Limited (GKBRPPL) under the 'issuer non-cooperating' category as GKBRPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GKBRPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 10, 2025, September 20, 2025, September 30, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

### About the Company

Established in 2011, GVR Khandaphod Bijwad Road Project Private Limited is a special purpose vehicle promoted by GVR Infra Projects Ltd to design, develop construct, operate, and maintain the 136-kilometre stretch of road between Khandaphod – Nachalbor and Bijwad – Kushmaniyan- Haran – Deepgaon. The project has been awarded by Madhya Pradesh Road Development Corporation Limited (MPRDC) on a semi-annual annuity of Rs.19.53 crore.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of GKBRPPL into Issuer Not Cooperating category vide press release dated April 04, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
