### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 13, 2024, placed the rating(s) of Sadashiva Oil Industries (SOI) under the 'issuer non-cooperating' category as SOI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SOI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 29, 2025, November 08, 2025, November 18, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Telangana Based, Sadashiva Oil Industries (SOI) was established in the year 2015 and promoted Mr. Umapathi and their relatives. The firm is engaged in manufacturing of cotton oil and cotton cake by crushing cotton seeds. The firm purchases its raw material from local suppliers in Hyderabad and converts them into oil and cakes used in poultry farms for feeding purposes. The firm supplies its finished products of cotton oil and cotton cake to the local customers located in Telangana.
