### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 13, 2024, placed the rating(s) of Amritlal Naresh Kumar (ANK) under the 'issuer non-cooperating' category as ANK had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ANK continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 29, 2025, October 09, 2025, October 19, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

ANK was established by Mr. Amritlal Naresh Kumar Gupta in the year 1997, as a proprietorship concern. ANK is engaged in the trading of imported timber. It primarily imports round timber logs from Singapore and Malaysia, which is subsequently sawn and sized into various sizes as per the requirement of the customers. The facility is located in Gandhidham, Kutch near Kandla port which facilitates easy imports and transportation of the products. ANK imports various types of timber such as Meranti, Kapur, Saal, Razzaq, Pine wood, etc. Mr. Amritlal Naresh Kumar Gupta and his son Mr. Sushil Kumar jointly manage the operations of ANK
