Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 26, 2024, placed the rating(s) of Bajaj Agro Industries (BAI) under the 'issuer non-cooperating' category as BAI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BAI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 12, 2025, October 22, 2025, November 01, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The firm has been engaged in rice milling activities at its plant located at Dhamtari, Chhattisgarh. The firm has started commercial operations from December, 2011 onwards. Mr. Naresh Bajaj has around 21 years of experience in rice milling industry and he looks after the day to day operations of the firm. He is supported by a team of experienced professionals.
