Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 29, 2024, placed the rating(s) of Santha Cashew (SC) under the 'issuer non-cooperating' category as SC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 15, 2025, October 25, 2025, November 04, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Firm

Santha Cashew (SC) was established as a Proprietorship firm in the year by Mr. K.G. Biju in a motive to set up a family business at Kollam, Kerala. The firm is engaged in processing of cashew kernals, cashew shells and raw cashew nut and export them to the customers located in middle east countries such as Saudi Arabia, UAE, Oman and also caters to domestic retailers located in Karnataka, Tamil Nadu, Andhra Pradesh and Kerala. The firm majorly import raw material (Raw cashew nut) from suppliers located in Africa and occasionally from domestic merchant located in Kerala to meet immediate order requirements.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of SC into Issuer Not Cooperating category vide press release dated March 17, 2025 on account of its inability to carry out a review in the absence of the requisite information from the firm.
