### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 22, 2024, placed the rating(s) of Anurag Poultry Farm (APF) under the 'issuer non-cooperating' category as APF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. APF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 08, 2025, October 18, 2025, October 28, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Hyderabad, Telangana based Anurag Poultry Farm (APF) is a partnership firm established in 2002 by Mr. Srinivas Rao, Smt. P Uma Rani, Mr. C Lakshmi Narsimha Rao, Mr. C Madhusudhan Rao, P Sharat Kumar and Ambience Constructions (I) Limited. The firm is engaged in layer bird farming and trading of eggs. The firm has an installed capacity of 8-layer sheds and 3 brooding sheds over 85 acres of land and consisting of 400,000 birds. The firm sells its products, i.e. eggs to local markets in Telangana and markets in and around Maharashtra. The firm purchases inputs for feeding of birds like maize, 3 Credit Analysis & Research Limited Brief Rationale soya, broken rice and minerals from local traders. The day-to-day operations are looked after by Mr. Srinivas Rao who is also the Managing Partner of the firm.
