Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 19, 2024, placed the rating(s) of Gepong (GG) under the 'issuer non-cooperating' category as GG had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GG continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 04, 2025, November 14, 2025, November 24, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Gepong was established in the year 1999 as a proprietorship entity. The entity was promoted by Mr. Nabam Tagi based out of Arunachal Pradesh. Since its inception, the entity has been engaged in civil construction activities in the segment of roads and other infrastructure projects. The entity participates in tenders and executes orders for the entities like North Eastern Indian Railways and Arunachal Pradesh Government departments.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of Gepong into ISSUER NOT COOPERATING category vide press release dated September 12, 2025 on account of its inability to carry out a review in the absence of requisite information from the firm.
