### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 11, 2024, placed the rating(s) of MDH Trucks Private Limited (MTPL) under the 'issuer non-cooperating' category as MTPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MTPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 27, 2025, October 07, 2025, October 17, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the company

Andhra Pradesh based, MDH Trucks Private Limited (MTPL) was incorporated in the year 2011 as a Private Limited Company by Mr.S.MD.Naveed (Managing Director) and Mrs. S.Feroza (Director). The operation of the company started in the year 2012. The company is an authorized dealer of Tata Motors Limited. The Company is engaged in sale of new vehicles and spare parts as well as servicing of vehicles. The vehicles sold by MTPL are small commercial vehicles (Tata Ace, Tata Magic, Tata xenon etc.), medium and heavy vehicles (Star bus, City ride, LPT'S etc.)

**Status of non-cooperation with previous CRA:** Acuite has continued the ratings assigned to the bank facilities of MTPL to the 'issuer not-cooperating' category vide press release dated August 25, 2025 on account its inability to carryout review in the absence of requisite information from the company.
