Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated January 03, 2025, placed the rating(s) of Srivenkateshwar Tradex Private Limited (STPL) under the 'issuer non-cooperating' category as STPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. STPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 19, 2025, November 29, 2025, December 09, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Incorporated in 2010, STPL is nestled in Delhi and owned by Solanki family. The company is managed by directors Mr. Rahul Solanki and Mr. Salender Solanki, and is involved in trading of various commodities like gold bars, rice, teak wood logs, and metal scrap etc.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of STPL into Issuer Not Cooperating category vide press release dated April 16, 2025 on account of its inability to carry out a review in the absence of requisite information.
