Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 27, 2024, placed the rating(s) of Global Aqua (GA) under the 'issuer non-cooperating' category as GA had failed to provide information for monitoring of the as agreed to in its Rating Agreement. GA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 13, 2025, October 23, 2025, November 02, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the firm

Global Aqua (GA) was established in June 2007 by one Mr Jayanta Chowdhury from Kolkata to initiate a fish trading and processing business in the state of West Bengal. However, after initiation, the entity acted as traders and suppliers for fresh sea foods like shrimp. Since FY15, GA has started outsourcing the shrimp processing & packaging to local processor and exports under its own name. Currently the entity procures fresh shrimp from local suppliers and after processing and packaging, exports (about 63% of total turnover in FY17) to the countries like Japan, Europe, Middle-east counties etc. The entity has agreement with Rupsha Fish Pvt Ltd., a local fish processor having facility near Kolkata, for processing and packaging of shrimp.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of GA into ISSUER NOT COOPERATING category vide press release dated July 28, 2025 on account of its inability to carry out a review in the absence of requisite information from the firm.
