Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 02, 2024, placed the rating(s) of Saktthi Footwear (SF) under the 'issuer non-cooperating' category as SF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 18, 2025, October 28, 2025, November 07, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Firm

Chennai based partnership firm, Saktthi Footwear (SF) was established by Mr. D Senthil Murugan and Mr. V. Lakshmi Narayanan in 1996. The firm is engaged in the manufacture and export of leather shoe uppers to customers in Germany, Portugal and Russia. The firm decided to start manufacture of full shoes in 2009 and two additional partners Mr. Kumaresa Pandian and his wife Ms. K Bhavani were admitted as partners. Mr. Kumeresa Pandian is the promoter of Blue Diamond Leders, another Chennai based leather manufacturer with expertise in manufacture of full shoes. The new partners brought in their expertise in full shoe manufacture and the existing partners' capital was divided among the new partners.
