### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 04, 2024, placed the rating(s) of Maspack Industries (MI) under the 'issuer non-cooperating' category as MI had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. MI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 20, 2025, October 30, 2025, November 09, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Surat (Gujarat) based Maspack Industries (MI) was established during January, 2014 by Mr. Sanjay Khaitan, Mr Rajiv Jain, Miss Shweta Junjunwala and Mr. Samarth Arya. MI is engaged in manufacturing of plastic bottles cap of A27W Alaska Neck Cap. The product is widely used in mineral water, juice and other bottle packing caps. MI has an installed capacity of 15 lakh caps per day as on March 31, 2016.
