Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 18, 2024, placed the rating(s) of Ozone Infra Projects (OIP) under the 'issuer non-cooperating' category as OIP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. OIP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 04, 2025, October 14, 2025, October 24, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Established as a partnership firm in April 2008 by Mr. B.T. Mishra, Mr. Ghanshyam Dubey, Mr. Keshrinath Vartak, Mrs. Manisha Patil, and Rohit Infra Projects Private Limited, Ozone Infra Projects (OIP) is engaged in infrastructure construction activities on an EPC (Engineering Procurement Construction) basis. The aforementioned partners were retired in January 2015, whereas the new partners viz. Mr. Santosh Pote, Mr. Changdeo Kadam and Mr. Shashikant Shinde were admitted during the same month.

Status of non-cooperation with previous CRA: India Ratings continues to categorize rating assigned to the bank facilities of OIP under non-cooperation category vide PR dated September 11, 2025 on account of its inability to carry out a rating surveillance in the absence of the requisite information from the Firm.
