### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 29, 2024, placed the rating(s) of Allflex Plastics LLP (APL) under the 'issuer non-cooperating' category as APL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. APL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 15, 2025, October 25, 2025, November 04, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Established in December 2014, Allflex Plastics LLP (APL) was promoted by Mr. Kamlesh Thakkar and Mr. Rushab Thakkar for setting up a manufacturing unit of flex banner. After successfully setting up its plant, the firm has commenced its manufacturing operations from April 2016. Prior to manufacturing operations, the firm was dealing with securities trading. The manufacturing facility of the firm is located at Howrah, West Bengal with aggregate installed capacity of 14400 pieces of flex banner per annum.
