Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 26, 2024, placed the rating(s) of Avinash Transport (AT) under the 'issuer non-cooperating' category as AT had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AT continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 12, 2025, October 22, 2025, November 01, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the firm

M/s Avinash Transport (AT), set up as a partnership firm in 2003 by Mr. Arvind Singh & his family members, based out of Dhanbad (Jharkhand), is mainly engaged in mining related excavation jobs encompassing removal of overburden, blast hole drilling, excavation, backfilling, sorting of rejects, grade wise stacking, lifting and transportation of the same. This apart, the firm also undertakes work for Eastern Coalfields Ltd. (ECL) and Bengal EMTA Coal Mines Ltd (EMTA)

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of AT into ISSUER NOT COOPERATING category vide press release dated July 10, 2025 on account of its inability to carry out a review in the absence of requisite information from the firm.
