Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 23, 2024, placed the rating(s) of Shri Venkateswara Trust (SVT) under the 'issuer non-cooperating' category as SVT had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SVT continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 08, 2025, November 18, 2025, November 28, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of SVT have been revised on account of non-availability of requisite information.

Shri Venkateswara Trust (SVT) was formed in the year 2009, to render educational and development services at Salem, Tamil Nadu. The trust operates three educational institutes namely 1. JSA Medical College for Siddha & Research Centre (offers ancient Siddha Medicine courses), 2. JSA College of Agriculture & Technology (providing agriculture and its allied technical courses, & agricultural science research programs), and 3. Jawaharlal Nehru College for Women (offers arts and science courses). All the three institute consists of well qualified and expertized principal and Head of the departments, with 124 teaching faculties and 95 non-teaching staffs. Total number of students altogether remained stable at 962 in past two AY ended 2020-2021.
