### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 27, 2024, placed the rating(s) of Shiv Dal Mill (SDM) under the 'issuer non-cooperating' category as SDM had failed to provide information for monitoring of the rating exercise as agreed to in its Rating Agreement. SDM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 13, 2025, October 23, 2025, November 02, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the company

Shiv Dal Mill (SDM) was established as a partnership firm via partnership deed dated August 20, 2014 by two partners namely Mr. Jakir Hossain and Mr. Montu Rahaman for setting up a manufacturing unit for processing of pulses of all varieties. The firm has already set up its manufacturing plant located at Murshidabad, West Bengal with aggregate cost of Rs.9.56 crore funded by term loan of Rs.5.00 crore and balance from partners' capital of Rs.4.56 crore. The plant became operational from April 2017.

**Status of non-cooperation with previous CRA:** ICRA has continued the rating assigned to the bank facilities of SDM into ISSUER NOT COOPERATING category vide press release dated September 15, 2025 on account of its inability to carry out a review in the absence of requisite information from the firm.
