### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated November 13, 2024, placed the rating(s) of Dhanvridhi Commercial Private Limited (DCPL) under the 'issuer non-cooperating' category as DCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 29, 2025, October 09, 2025, October 19, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the company

DCPL was incorporated in November, 2005 by the Tantia family of Kolkata, West Bengal. Initially, DCPL was engaged in trading of materials required for railway wagons. Subsequently, from FY2010-11, the company started manufacturing of railway wagons and fabrication jobs on contract basis. The manufacturing facility of the company is located at Baruiapur, West Bengal.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of DCPL into ISSUER NOT COOPERATING category vide press release dated February 14, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
