### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 02, 2024, placed the rating(s) of Shrinath Cotton Industries (SCI) under the 'issuer non-cooperating' category as SCI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SCI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 18, 2025, October 28, 2025, November 07, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the firm

Shrinath Cotton Industries (SCI) is a partnership firm established in 2006 by three partners Mr. Keshavlal Popat, Mr. Bharat Popat and Mrs. Raksha Popat which was later reconstituted with the retirement of Mr. Keshavlal Popatas on January 18, 2011. It is now managed by Mr. Bharat Popat and Mrs. Raksha Popat and has its manufacturing facility at Amreli district, Gujarat. SCI is engaged in the cotton ginning and pressing business. The firm is ISO 9001:2008 certified and Technology Mission on Cotton (TMC) approved firm by the Ministry of Textile, GOI. As on March 31, 2017, SCI had a total installed capacity of 24,000 bales of cotton and 6,133 metric tonne per annum (MTPA) of cotton seed.
