### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated January 09, 2025, placed the rating(s) of Patel Phoschem Limited (PPL) under the 'issuer non-cooperating' category as PPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 25, 2025, December 05, 2025, December 15, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Udaipur (Rajasthan) based Patel Phoschem Private Limited (PPL) was incorporated in 2006 by Mr. Roop Lal Patel along with his family members. In April, 2014, the company changed its constitution from private limited to public limited. Initially, PPL was engaged in the business of executing turnkey projects related to installation of fertiliser plants which includes construction of plant to supply of machineries. Later, from September, 2012, PPL started production of SSP, GSSP and PA.
