Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 04, 2024, placed the rating(s) of S. Gurusiddaiah (SG) under the 'issuer non-cooperating' category as SG had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SG continues to be non-cooperative despite repeated requests for submission of information through e-mails dated October 20, 2025, October 30, 2025, November 09, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Karnataka based, S. Gurusiddaiah (SG) was established as a proprietorship firm in the year 2013 and promoted by Mr. S. Gurusiddaiah. The firm is engaged in providing warehouses on lease rental basis. The rural godowns are used for storage of various consumer goods such as bricks, cement bags, paint cans, cables, wires, etc. Commercial operations for two godowns were started in 2016 and for third godown, the commercial operations started from September 2018. Some of the regular customers of the firm are Bharti Airtel Limited, Alpha Packaging Private Limited, Sami Labs Limited and Athara Oil Industry, from whom the firm earns revenue by sale of sites, for the storage of various goods. Apart, the firm is also engaged in trading of various goods such as bricks, cement bags etc. to local customers.
