Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated December 19, 2024, placed the rating(s) of Shristi Ispat & Alloys Limited (SIAL) under the 'issuer non-cooperating' category as SIAL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SIAL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 04, 2025, November 14, 2025, November 24, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of SIAL have been revised on account of non-availability of requisite information.

SIAL, incorporated in 2004, is engaged in manufacturing and selling of TMT bars and rounds, with an installed capacity of 84,000 MTPA at Bankura, West Bengal. SIAL markets its product in West Bengal and Assam. The day-to-day affairs of the company are looked after by Mr. Sanjay Kumar Dalmia and Mr. Santosh Kumar Kedia, with adequate support from other three directors and a team of experienced professionals.

Status of non-cooperation with previous CRA: Acuite has continued the rating assigned to the bank facilities of SIAL into ISSUER NOT COOPERATING category vide press release dated August 13, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
