### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated January 07, 2025, placed the rating(s) of Balasaheb R. Bhadane (BRB) under the 'issuer non-cooperating' category as BRB had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BRB continues to be non-cooperative despite repeated requests for submission of information through e-mails dated November 23, 2025, December 03, 2025, and January 30, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

### About the company and industry

Balasaheb R Bhadane (BRB) is a Dhule, Maharashtra based civil contractor for both Central and State Government which commenced its operations in 1993. BRB is a proprietorship concern formed by Mr. Balasaheb R Bhadane. It is registered as a Class 1A contractor with Public Works Department (PWD) Government of Maharashtra (GoM) and has tendered various contracts involving construction of roads, bridges, railway tracks, row houses, school buildings, government hostels, etc.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of BRB under Issuer Not Cooperating category vide press release dated October 06, 2025 on account of its inability to carry out a review in the absence of the requisite information from the firm.
