Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated January 28, 2025, placed the rating(s) of Goyal Motors (GM) under the 'issuer non-cooperating' category as GM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated December 14, 2025, December 24, 2025, January 03, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Prior to commencement of operations, the firm was engaged in the sale of only spare parts of Tata Motors Ltd. and sale of second-hand passenger vehicles. Presently, the firm is an authorized dealer of TML and is engaged in the sale of passenger vehicles, servicing of vehicles and sale of spare parts. The firm owns & operates a showroom in Patiala (started operations from May2016), providing 3S (sales, service and spare parts) facilities.
